violate the terms of their post release community supervision prcs if a violation occurs the law permits the court to modify or revoke prcs or refer the person to reentry court post release community supervision is an alternate form of parole whereby the county board of parole department of corrections and community Jun 23 2022 it is an independent body responsible for determining parole setting parole conditions and revoking parole when conditions have been violated individuals who have been approved for release but who still have time on their sentence must complete it on community
